1 WHEREAS on July 21, 2016, this Court granted preliminary approval of Indirect Purchaser
2 Plaintiffs' (IPPs), settlements with the Panasonic Corporation and Panasonic Corporation of North
3 America, NEC Corporation, Sony Corporation, Sony Optiarc Inc. (formerly known as Sony NEC
4 Optiarc Inc.), and Sony Optiarc America Inc. (formerly known as Sony NEC Optiarc America Inc.),
5 Hitachi-LG Data Storage, Inc., and Hitachi-LG Data Storage Korea, Inc. (collectively, "Settling
6 Defendants");

7 WHEREAS IPPs propose to have an additional vendor added as a Settlement Administrator,
8 which will aid in providing the most efficient and cost effective notice and administration of the
9 settlements as possible; and

10 WHEREAS the Settling Defendants do not object.

11 NOW, THEREFORE, IT IS HEREBY ORDERED:

12 1. The Court appoints the firm Sipree, Inc. in addition to Gilardi & Co. LLC, to
13 supervise and administer the notice procedure as well as the processing of claims as more fully set
14 forth in the Order Granting Indirect Purchaser Plaintiffs' Motion for Preliminary Approval of Class
15 Action Settlements with Panasonic, NEC, Sony and HLDS Defendant Families and Dissemination of
16 Class Notice, ECF No. 1916.
